

MAGISTRATES COURT OF TASMANIA

Practice Direction I of 2022 Criminal and General Division Court Practices

- Practice Direction No. 4 of 2020 is revoked on 31 January 2022.
- This Practice Direction will commence on 31 January 2022.

GENERAL

- Those entering the Court must comply with COVID-19 safety standards as well as the directions of court staff and security officers. Those who do not comply may be required to leave the Court building.
- Face masks must be worn at all times in all public areas including waiting areas, court rooms, conference rooms and amenities, except if directed to remove the mask by an authorised person.

Exemptions to wearing of masks apply for the following persons:

- o Children aged under 12 years or a student at primary school; or
- Anyone with a medical exemption which certifies that the person has a physical or mental health illness, condition or disability that makes the wearing of a face mask unsuitable. Evidence of a medical exemption must be provided on request when entering the building.
- Details relating to the conditions of entry to the Magistrate Court buildings are available on the Magistrates Court <u>website</u>.
- The Court is committed to continuing the use of audio and audio visual links wherever appropriate.
- Any person who is not a participant in the proceedings may be required to remain outside the court building.

APPEARING BEFORE THE COURT

- Appearances before the Court may be in person or by audio or audio visual link, as the magistrate directs.
- Lawyers who wish to appear by audio or audio visual link, or whose clients wish to, must complete the audio/audio visual conference booking form.
- If you do not have a lawyer and you wish to appear by audio or audio visual link, you must complete a booking form.
- The audio/audio visual conference booking form is available on the Court's website at:
 <u>Conference Booking Form</u>. You must complete a booking form and return it to the Court at least 2 days before your court date if possible.
- If you are unable to complete the audio/audio visual conference booking form you may provide your email/telephone details to the Court using the contact details below.

Appearance by People in Custody

 Wherever possible people in custody may appear by audio or audio visual link, unless a magistrate directs otherwise.

Hearings

• The hearing of contested matters in person may resume provided they can be conducted in a manner that is safe and consistent with public health guidelines.

- Wherever possible family violence order and restraint order applications should be lodged by email. Restraint Order Applications should be accompanied by a completed credit card payment form. EFT payments may be made by telephone.

- Lawyers, other service providers, and/or young people may appear in person or by audio or audio visual link, as the magistrate directs.

Child Protection

- Applications may be dealt with in person or by audio or audio visual link, as the magistrate directs
- Applications and any supporting documentation under the *Children*, *Young Persons and Their Families Act* 1997 must be lodged by email to the relevant registry email address:

continue to be listed and may be in person or by audio or audio visual link, as the conciliator
directs.

Court Mandated Diversion

• Court Mandated Diversion proceedings may be in person or by audio or audio visual link, as the magistrate directs.

Mental Health List

• Mental health diversion list proceedings may be in person or by audio or audio visual link, as the magistrate directs.

Restricted Licence Applications

- The hearing of restricted licence applications may be in person or by audio or audio visual link, as the magistrate directs.
- Wherever possible restricted licence applications should be lodged by email. Restricted Licence applications should be accompanied by a completed credit card payment form. EFT payments may be made by telephone.
